Invitation for Tenders

 - Establish appropriate rental rates by conducting market research, determining costs and considering profits goals;
 - Enforce terms and conditions of rental agreements and ensure timely payment and collection;

- Monitor and complete maintenance and repairs timely and cost effectively;
- Orient new tenants to the property and enforce occupancy policies and procedure.
- 2. Zanzibar Social Security Fund invites all eligible providers for Letting and Management of ZSSF Real Estate and Buildings Properties Located in Zanzibar specifically ZSSF Office Building (Chake Pemba) and Mapinduzi Tower Mapinduzi Square, Michenzani.
- 3. Tendering will be conducted through the National Competitive procedures specified in the Public Procurement Act number 11 of 2016.
